## Questionnaire for ITUC Regional Organisations, National Trade Union Centres, and GUFs on EU Development Cooperation Instruments Consultation Process

**Context:** The European Commission (EC) is currently undertaking the revision of the main financial instruments in the field of development cooperation, which are:

- Development Cooperation Instrument-DCI (covering Africa, Asia, Latin America, and Eastern Europe/Mediterranean area)
- European Development Fund EDF (for ACP countries).

By 2010 is due to be completed the so called **mid-term review** of these Instruments, which will entail a first evaluation of the outcomes produced until present.

This process is carried out by the EC with the support of <u>CONSULTATION</u> rounds with the major development Civil Society Organisations, both at central level (Brussels) and at region/country level.

**Purpose**: ITUC is willing to engage in the mid-term review process of both DCI and EDF, aiming at <u>prioritizing the role of Trade Union Organisations in development cooperation</u>.

To this end it is necessary to build up a shared advocacy strategy towards the Commission, based on effective cooperation and working methodology among ITUC Brussels, ITUC Regional structures, National Trade Union centres, and GUFs.

The Questionnaire below is supposed to gather feedbacks from ITUC Regional Organisations, GUFs, as well as, National Trade Union Centres in order to collect evidence, experience and suggestions to lobby the EC effectively, as well as, to improve our internal advocacy coordination.

- 1) get stock of the consultation process;
